Terms and conditions

To access the website <u>www.soul-date.net</u>, users must first complete the registration process. By registering, the user agrees to the following terms governing the use of this site. These rules are designed to protect all members (both men and women) from any unlawful or fraudulent activities and to ensure that everyone who joins and uses the platform can do so in a safe and secure environment.

1. Subject of the contract

- 1.1 Registration on the website is free of charge. In addition, SoulDate provides optional paid services.
- 1.2 Subject of the contract is the use of the services and features provided by SoulDate on the website. These include uploading personal content, creating user profiles, accessing other users' profiles, and communicating with other members. Your use of the services begins, and you agree to these terms, once you confirm your registration.

2. Membership

- 2.1 To become a member of SoulDate and access to the website you must:

- Not have been convicted of any violent or sexual offenses in any country.
- Not be legally married.

- Refrain from using the website for any unlawful purposes.
- Provide accurate and truthful personal information when using the website and communicating with other members.
- Not use the website for illegal activities, sending chain letters or spam, or to harass, abuse, solicit, or advertise to other members.
- Not seek any financial benefit from contacts made through the website, and avoid using obscene language or sharing explicit images in any form of communication.
- 2.2 The content of the website is owned by SoulDate and is protected by copyright, trademark, and other intellectual property laws. You are prohibited from using any information obtained from the website in any unauthorized manner.

3. Credits, payment

- 3.1 Registration on the platform is free of charge.
- 3.2 To access additional features on the platform, users may purchase credits.

- 3.4 Credits do not have an expiration date.

4. Communication, Prohibited contents

9. Refund Policy for Services
